#### T5.3Project Administration & Finance

Administration: supports project management by:

- Maintain secure access to the Project Wiki on confluence as a secure easy to use space
- WP specific collaborative space
- EB meetings will keep record of discussions on progress etc.
- Contacts: WP mailing lists
- General assembly once a year next GA end of 2023
- Will request partners to nominate 1 main and 1 deputy (specific mailing list will be created for this)
- Distribution of Pre-financing
- 80% (less ~5% contribution to Guarantee Fund)
- ECMWF Finance department has already been in contact for bank details
- Payments to be distributed shortly (after internal processes have been completed)
